This is in continuation to this office letter no. F.11(111)/2012/Power /716 dated 04th March, 2015 on the subject cited above. In this regard, I am directed to further clarify as per the following :-

- i) To extend 50 per cent subsidy to domestic consumers in the first two tariff slabs covering 0-200 units/month and 201-400 units/month for the 1 month period from 1st March, 2015 to 31st March, 2015 and for the period from 01st April, 2015 to 31st March, 2016;
- ii) No subsidy shall be provided to domestic consumers consuming more than 400 units per months;
