## NOTICE INVITING APPLICATIONS FOR APPOINTMENT OF TWO 'PROTEM' MEMBERS, DELHI ELECTRICITY REGULATORY COMMISSION

Pursuant to the directions of the Hon'bie Supreme Court of India, vide its Order dated 06.11.2023 in the matter of W.P.(C) No. 1222/2023 titled as Government of NCT of Delhi vs. Union of India & Others, the Selection Committee has decided to call Applications from eligible candidates for appointment of two protem Members of the Delhi Electricity Regulatory Commission (DERC).

## QUALIFICATION:-

The Member of the Delhi Electricity Regulatory Commission shall be a person of ability, integrity and standing who has adequate knowledge of, and has shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management, in accordance with Section 84(1) of the Electricity Act, 2003.

The Terms and Conditions of service of Member: The terms and conditions of service of protem Members shall be governed as under:-

- The Member shall hold office till the outcome of the proceedings which are pending before the Constitution Bench involving a challenge to the constitutional validity of the GNCTD (Amendment) Act, 2023.
- (2) Applicant should have minimum 20 years of Managerial Experience in the Central Government, State Government, Union Territories, Autonomous or Statutory Bodies, PSUs or Electricity Boards. Applicant should have been drawing pay at the Pay Level 15th of 7th CPC.
- (3) As per Section 89 of the Electricity Act, 2003, Member shall not hold office after attaining the age of 65 years. The applicant should not have completed 62 years of age as on 08.12.2023 i.e. those born on or after 08.12.1961 are alone eligible to apply.
- (4) The Member shall, before entering upon his office, make and subscribe to an oath of office and secrecy as prescribed in DERC (Salary, Allowances and Other Conditions of service of the Chairperson and Members) Rules, 2001.
- (5) The Member may -
  - relinquish his office by giving in writing to the Appropriate Government a notice of not less than three months, or
  - (b) be removed from his office in accordance with the provisions of section 90 of the Electricity Act, 2003.
- (6) The Member shall receive a pay of Rs. 2,25,000/- (Rupees Two Lakh Twenty Five Thousand) (fixed) per month along with other allowances as applicable provided that in case a person appointed as Member is in receipt of any pension, the pay of such person shall be reduced by the given amount of pension drawn by him.
- (7) Persons having financial or other interest which is likely to affect prejudicially his functions as Member of the Commission are not eligible.
