## Qualification: -

The Member of the Delhi Electricity Regulatory Commission shall be a person of ability, integrity and standing who has adequate knowledge of, and has shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management. (As per Section 84(1) of the Electricity Act, 2003).

<u>The Terms and Conditions of service of Member:</u> The terms and conditions of service of a Member shall be governed as per section 89 of the Electricity Act, 2003. The relevant extract of the aforesaid provision is reproduced as under:-

- (1) The Member shall hold office for a term of five years from the date on which he enters upon his office or till he attains the age of 65 years whichever is earlier.
- (2) The Member shall, before entering upon his office, make and subscribe to an oath of office and secrecy in such form and in such manner and before such authority as may be prescribed.
- (3) The Member may -
  - (a) relinquish his office by giving in writing to the Appropriate Government a notice of not less than three months, or
  - (b) be removed from his office in accordance with the provisions of section 90 of the Electricity Act, 2003.
  - (4) Any Member ceasing to hold office as such shall: -
    - (a) not accept any commercial employment for a period of two years from the date he ceases to hold such office; and
    - (b) not represent any person before the Central Commission or any State Commission in any manner.

- (5) The salary, allowances and other terms and conditions of service shall be governed by Delhi Electricity Regulatory Commission (Salary, Allowances & Other Conditions of Service of the Members) Rules, 2001. The Member shall receive a pay of Rs. 2,25,000/- (Rupees Two Lakh Twenty Five Thousand) (fixed) per month provided that in case a person appointed as Member is in receipt of any pension, the pay of such person shall be reduced by the given amount of pension drawn by him.
- (6) Persons having financial or other interest which is likely to affect prejudicially his functions as Member of the Commission are not eligible.
