Department of Power, Govt of NCT of Delhi invites applications on deputation/ contractual basis for the post of Member (Technical) in Public Grievance Cell (Electricity) from amongst retired/serving Chief Engineer rank officer of Government /PSU having at least 15 years of experience of Generation, Transmission and Distribution in Power Sector. Experience in distribution sector will be preferred. The Selected Candidates would be offered the post for the period of one year or till attaining the age of 65 years whichever is earlier. Government reserves the right to abolish the post at any time.

**1. Remuneration:-**

- a. In case of appointment on deputation basis, the pay scale of Rs. 37400-67000, GP Rs.10000 (6th Pay Commission) plus other allowances as applicable.
- b. For Contractual appointment: a consolidated amount of Rs.30000/-plus conveyance & mobile phone facility will be applicable

OR

- c. Last pay minus Basic Pension plus DA at the applicable rate. However, a retired Government official shall continue to draw pension and dearness relief thereon during the period of his engagement as a Consultant as per OM NoF.20/47/2015-AC/204-248 dated 04.12.2015 issued by the Finance Department, Govt of NCT of Delhi. His/her engagement as consultant shall not be considered as a case of re-employment.

Selected person may accept one of the two options given in 1(b) and 1(c) above. He may revise the option at any time during the tenure by giving one month's notice.

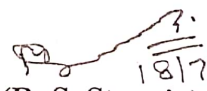
**2. Tenure:-**

Initially for a period of one year. However, can be extended further subject to the satisfactory performance of and depending upon the specific job and the time frame for its completion. The total period of engagement shall not exceed 5 years. The maximum age limit for engagement as consultant shall be 65 years.

**3. Age limit:-**

- a. For officers on deputation basis –not more than 56 years.
- b. For contractual appointment – not more than 62 years.
