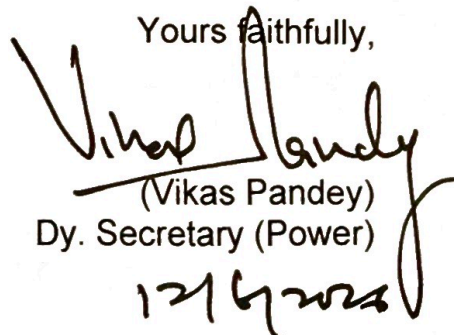

**NOTICE INVITING APPLICATIONS FOR CHAIRPERSON AND
TWO MEMBERS IN DERC**

Applications are invited from the eligible candidates for the selection of Chairperson and two Members of Delhi Electricity Regulatory Commission (DERC).

Qualifications:

The Chairperson and Member of the Delhi Electricity Regulatory Commission shall be a person of ability, integrity and standing who has adequate knowledge of, and has shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management.

Additional and essential requirement of Legal/Judicial Member:

As per judgment dated 12.04.2018 of the Hon'ble Supreme Court of India in Civil Appeal No.14697 of 2015 titled "*State of Gujarat & Ors. Vs. Utility Users' Welfare Association & Ors.*", wherein it has been held that it is mandatory that there should be a person of law as a Member of the Commission. For this purpose, the candidate should be:

- (a) a person who is or has been holding a judicial office; or
- (b) an advocate with not less than ten years' practice and qualified for appointment as a Judge of a High Court under Article 217(2) of the Constitution of India; or
- (c) an advocate with not less than seven years' practice and qualified for appointment as a District Judge under Article 233(2) of the Constitution of India.

Terms and Conditions of service of Chairperson and Members:

- (1) The Chairperson and two Members shall hold office for a term of five years from the date on which he enters upon his office or till he attains the age of 65 years which ever is earlier. The Chairperson or other Member in the State Commission shall not be eligible for re-appointment in the same capacity as the Member in that Commission in which he had earlier held office.

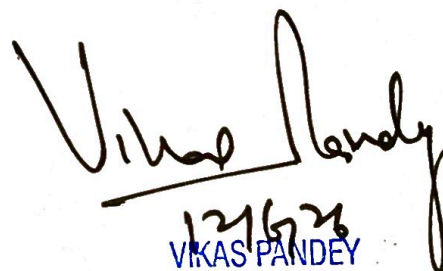

- (2) The salary, allowances and other terms and conditions of service of the Chairperson and Members in DERC shall be governed as per Section 89 of the Electricity Act, 2003 readwith Delhi Electricity Regulatory Commission (Salary, Allowances & Other Conditions of Service of the Chairperson & Members) Rules, 2001 (as amended from time to time).
- (3) The Chairperson and Member shall receive a pay of ₹2,25,000/- (Rupees Two Lakh Twenty Five Thousand)(fixed) per month provided that in case a person appointed as Chairperson and Member is in receipt of any pension, the pay of such person shall be reduced by the given amount of pension drawn by him.

HOW TO APPLY AND LAST DATE FOR APPLICATION

Eligible candidates may submit their applications for the posts of **Chairperson** and **two Members** of the Delhi Electricity Regulatory Commission (DERC), along with a detailed bio-data and a duly filled application format at **Annexure-I**.
